



The Chautauqua Lake High School Baseball program would like to request the use of Prommenschenle Stadium on the evening of Thursday, June 14th, 2012 (rain date: Friday, June 15th, 2012) for the purpose of hosting the 2012 Chautauqua County Exceptional Senior All-Star Softball game. Attached to this letter is our application for use of the field as well as proof of our insurance – specifically naming the City of Dunkirk as additionally insured.

We have been the proud sponsor of senior all-star games for both baseball and softball in Chautauqua County since 2010. That year, we held both games side-by-side at SUNY Fredonia. In 2011, we chose to host both games at night, on different days, with one in the South County (baseball game at Diethrick Park in Jamestown) and one in the North County (softball game in Dunkirk). The Common Council graciously approved our request.

Unexpectedly, six of the sixteen schools in Chautauqua County did not have a single senior on their varsity softball team last spring. As a result, we did not have enough participants for two complete rosters for the softball game. This forced us to make the difficult decision to cancel the game – a situation we do not foresee happening again this year. The baseball game was played and was a huge success. A Dunkirk student-athlete was the MVP!

With your approval, we would like to give the 2012 softball game the proper stage that it deserves. We have been in contact with Mayor Dolce and Mr. Rozumalski in the Parks and Recreation Department and, pending your approval, will coordinate parking with the City of Dunkirk Police Department – as we did in advance of last year's anticipated game.

DUNKIRK CITIZENS' ADVISORY COMMITTEE

At the March 14, 2012 meeting of the Dunkirk Citizens' Advisory Committee, the following recommendation was approved unanimously for submission to the City of Dunkirk Mayor and Common Council:

Auditor Rotation

The Citizens Advisory Committee ("CAC") serves the City of Dunkirk ("City") and its residents in an advisory capacity. As such, the CAC recommends that the City of Dunkirk institutes an auditor rotation policy that addresses a number of issues such as maintaining objectivity and ensuring competitive pricing. Recommendations to this policy include:

- Independent Audit services be put out to bid no less than every three (3) years
- After an independent auditing firm has served for three (3) consecutive years, that firm may again bid for another three (3) year term using another partner to oversee the City's audit
- After serving six (6) consecutive years as independent auditing firm for the City that firm may not bid again for a period of three (3) years
- No independent auditing firm serving the City may also serve simultaneously as the auditor for separate but related City entities (i.e., the DLDC)
- After serving the City or a separate but related City entity (i.e., the DLDC) the independent auditing firm may not serve the other entity for a period of at least one (1) year.

Recommendation is made for implementing during the present calendar year and then including as a modification to the City of Dunkirk Charter.


